Erik Martin and Matt Dillin gave a briefing of the expenditures. The group discussed the communications work being done by HDR.

Motion made by Supervisor Swope to approve the invoices totaling \$231,237.47. Supervisor Pollock seconded the motion.

Motion approved 3-0.

#### SAO Exit Conference – Alisha Alkire, State Auditor's Office

Lisa Carrell and Alisha Alkire from the Washington State Auditor's Office (SAO) discussed the 2018-2021 audit of the flood control zone district.

Alisha said the SAO looked at accounts payable, compliance with state grants, procurement of professional services, open public meetings and the overall financial position. In those selected areas, the district complied in all material respects, with applicable state laws, regulations, and its own policies and provided adequate controls over the safeguarding of public resources.

Alisha thanked the district staff for providing information in a timely manner.

Lisa discussed the audit costs and noted the next audit will be conducted in 2025.

## Project Update

Matt Dillin reported the consultants are working on minimization alignments. The original alignment of the structure directly impacted a sensitive cultural resource. HDR is currently looking at an alignment downstream and upstream of the original alignment. The early results are showing positive so far. One of the benefits of the minimization alignments the district was hoping to find is that the district could have an open channel fish passage during construction, which was a significant impact. Meetings have been held with WDFW on the conceptual preliminary design on having an open channel fish passage. Both the downstream and upstream designs are looking feasible to allow for the open channel fish passage.

Geotechnical data is currently being collected for the two alignments. HDR has been out in the field a couple of times and they do not anticipate any major concern when the drilling information comes back.

The district has had some coordination with National Marine Fisheries Service (NMFS) and the interactions have been positive.

The district has also been having monthly meetings with the Dept. of Ecology and the Army Corps of Engineers staff and their technical review experts. They have responded with good feedback on the mitigation plan and vegetation management plan. They have asked for more quantitative detail information and the district will need to do a higher level of detail design to answer those questions.

Matt said that OCB has agreed to give the district more funds in the next biennium to start working on a more detailed design.

The district also received an extra \$3 million for this biennium to start the more detailed investigation.

Matt also said the district has received some good feedback from the community. The district's wetland specialist came out a few weeks ago to visit his top 5-wetland mitigation sites.

The next phase of the mitigation plan is to take it from the desktop to feet on the ground to see what is on the properties. This requires more community outreach to access the properties. Out of the five properties, four landowners agreed to let the wetland specialist on their property.

Erik said the district has been slotted for \$20 million that OCB has asked the legislature for. The district is hopeful that the funding will be approved. That will allow the district to go to the level of design that is needed to show how the fish passage will work for the project.

Edna Fund noted that due to other requests, OCB opted to \$73 million in their request due to the legislature.

#### **OCB Update**

Erik reported the land committee had a meeting last week at the Great Wolf Lodge and presented some different alternatives to flooding.

Supervisor Brummer said the options are suitable and can be effective options in conjunction with the flood control structure. He does not feel they will be adequate as standalone options to control flooding. He also noted the price tag is very expensive.

J. said the high level of work the committee did was very good. He noted that some members that attended were focused on the Skookumchuck River. He further discussed the meeting.

Erik noted that Jim Kramer, who was the OCB facilitator, has retired.
