AMENDMENT #2 to PERSONAL SERVICES AGREEMENT between the CHEHALIS RIVER BASIN FLOOD CONTROL ZONE DISTRICT and GORDON THOMAS HONEYWELL GOVERNMENTAL AFFAIRS

THIS AMENDMENT #2 is made and entered into by and between the CHEHALIS RIVER BASIN FLOOD CONTROL ZONE DISTRICT ("District") and GORDON THOMAS HONEYWELL GOVERNMENTAL AFFAIRS ("Contractor").

IT IS THE PURPOSE OF THIS AMENDMENT to extend the attached personal services agreement, executed on July 6, 2023 and amended on June 24, 2025, by one more month so that it ends on August 31, 2025.

The attached agreement shall continue in full force and effect through August 31, 2025. The period of performance shall be so extended, and Contractor, through Jim Waldo and if applicable John Robinson, shall continue to perform the same services through that date.
